#### Comments

Program advisor Mirian Espinosa conducted an announced agency inspection on October 15, 2024, to assess compliance with requirements under the Child Care and Early Years Act, 2014. Met with licensee Jennifer Fram, supervisor Katherine Glover and home visitor Paulina Silvera.

Home premise inspections were conducted on October 9, October 10 and October 15, 2024, along with home child care visitor Paulina Silvera.

At the time of inspection, at 1 of the home premises inspected, the provider informed program advisor that they have previously obtained their Early Childhood Education credentials, however they have not and do not plan to register with the College of Early Childhood Educators. During the agency inspection, program advisor informed licensee that this provider is working within the scope of practice of early childhood education defined in the Early Childhood Educators Act, 2007. As discussed with the licensee, a referral will be made to the College of Early Childhood Educators by the program advisor, further information, can be obtained by contacting the College at registration@college-ece.ca.

During the home premise inspections, program advisor observed the following:

-At 1 of the 6 homes, the provider was observed siting on the floor reading a story to a child while child sat on their lap, another child approached and pointed, the provider asked the child if they also wanted to sit, child nodded yes and provider made room on their lap for the child to sit. Both children sat on the provider's lap listening to the story.

-At 1 of the 6 homes, the provider was heard telling children what they will be eating for lunch today and what they will have the next day. Children attempted to vocalize the foods the provider mentioned. Provider was observed supporting children to sound out the phonic sounds of the words ex (aaaple) and the children can be heard repeating the words. During lunch time, the provider was observed cutting the apples and carrots in very small pieces and larger pieces for the older children and continued to labelled the food items as children continued to point and make sounds.

-At 1 of the 6 homes, the provider was observed sitting with the children as they ate their yogurt and pancakes. Soft music can be heard playing in the background. Following the snack time, the provider can be heard singing "This is the way we wash our hands" as she supported the children to wash their hands.

-At 1 of the 6 homes, the provider can be heard using verbal communication and sign language to communicate with the children. Children and provider can be see using the sign for "all done" and "more". Provider can be heard acknowledging the children's attempt to communicate by verbalizing the children's cues and sounds. Provider can be heard stating, "are you okay", "do you want more", "are you all done?".

-At 1 of the 6 homes, the provider advised that the children really enjoy outdoor play as it allows them to explore in a different way than indoors and the fresh air is good for the well being of the children and herself as the provider. For this reason, provider informed that they spend more than 2 hours outdoors either at the park or on the yard at the home premises.

-At 1 of the 6 homes, the provider was observed supporting children with dressing "babies". The children and provider were observed dressing the dolls and children were observed using blankets to cover the babies. The provider can be heard talking to the children about their actions and how to carry the babies.

These observations are reflective of the agency's goal to support positive and responsive interactions among providers and children, encourage the children to interact and communicate in a positive way and support the children's ability to self-regulate. The goals are reflective of the approaches outlined in the program statement which states, "Little Leaders program is built on the concrete beliefs that children are competent, capable of complex thinking, curious and rich in potential. With this in mind, we provide children with the ability to learn in a way that will most benefit their personal growth. Furthermore, with each interaction, our providers are mindful of the four foundational conditions essential for children's growth: Belonging, Well-Being, Engagement, and Expression."

During the agency inspection, program advisor reviewed the CCLS profile data, specifically the agency civic address, licensee/agency contact information and operational information with licensee to confirm information is up to date and accurate.

#### Recommendations

#### Comments continue:

Policies and procedures have been deemed compliant in the past and the licensee has confirmed that these documents have not undergone changes since it was last assessed, with the exception of the Safe Arrival Policy and Parent Handbook. As a result, these documents have not been re-assessed for compliance during this inspection, with the exception of the Safe Arrival Policy and Parent Handbook; these 2 documents were reviewed at the time of inspection.

During the home premise inspections, program advisor noted that records retention, processes and procedures have been streamlined by the licensee. For example, the providers were all observed to use the same method to document children's attendances, sleep checks and daily written records. Licensee acknowledged that this change is better supporting oversight as it is simpler and more efficient.

Program advisor reviewed the conditions on the licence with licensee. The condition pertaining to the implementation of the oversight and governance plan submitted to the Ministry on February 8, 2024 will be recommended to be removed from the licence.

#### Recommendations:

At the time of the home premise inspection, the individual medical plan reviewed did not require the parent to input information about procedures to follow during an evacuation or filed trip. It is recommended licensee use the ministry's templates to ensure all required information is obtained on the individual plans.
